Background:

Indicators of child growth are used across the globe for:

- Monitoring the nutritional status of a population
- Making comparisons across countries
- Developing health policy and interventions

Current indicators used by the World Health Organisation define general standards to be applied across countries and socio-economic conditions. Such standards have important drawbacks as they include parameters from medical theories and practices only (e.g. growth, body mass, energy intake) and do not take into account the socio-cultural and biological context in which most children live.

Researchers from a variety of disciplines are invited to participate in this workshop to help thinking about a multi-dimensional understanding of child growth. Anthropologists are particularly needed for improving our understanding of what healthy growth in different countries, in different stages of development and of the nutrition transition means to mothers, fathers, health professionals and policy makers.

Aim:

To discuss my research on healthy growth (need for multi-dimensional indicators of child growth) with scientists and professionals working at international organisations in order to establish a platform where this discussion can be continue after the workshop.

To come to a shared focus of the Task-Force for the period September 2013 – September 2017 following this discussion.
